HR Strategy & Compliance

- Implement data protection and employee confidentiality policies.
- Register with regulatory bodies (PENCOM, NSITF, NHF) for compliance.

- Ensure timely remittance of PAYE tax, pension contributions, and deductions.
- Offer competitive employee benefits (health insurance, bonuses, training).
